The Local Government Act 1972 allows a parish council to change its name to a community council, among other styles, without altering its legal status or powers. This flexibility is part of the Act's provisions to adapt to the changing nature of parishes and their communities.

The process involves a signed petition by at least 7.5% (Approximately 320 names) of the local electorate, followed by a governance review by the local authority to assess the request and make a final decision.
